


# **President's Thoughts**

I can tell you FWIC had a very difficult time making their decision and I was glad I was not one of the people having to make the decision.

Our MWI mail-in AGM 2021 ballots were counted by Angela with the help of two non-MWI scrutineers. We appreciate these ladies sharing their time to help MWI count and document our member's votes. # MEET A MEMBE

I spent time in a delightful conversation with **Pearl Homick from Fisher Branch Women's Institute**. Pearl told me she attended conventions and annual meeting years ago but now at 93 she isn't up to attending them. But she was delighted to have the opportunity to cast her vote in AGM's in 2020 and 2021. Covid and all related to it made us rethink how we do things and good has resulted in allowing more members to vote and be part of the AGM decisions.

As lots of conversations start, we talked about where we were from and in her case where she had moved from (her husband worked for the railroad so she moved lots). She had lived in Miami Manitoba and worked as a telephone operator (hourly wage 25 cents an hour). As coincidence would have it my father's cousin owned the Drug Store in Miami and she knew him and his family.

Pearl has been a hard worker for the WI movement, a member for over 50 years, secretary for 18 years, has kept records of all the members since 1948 when their branch started. She has all the meeting journals except one which was destroyed in a fire.

We talked about finding it difficult to attract members but she knows young mums today have lots to do and time is precious. But the young women in her community do help with WI events if asked. She is on the phoning committee and keeps members in the know. I asked what stands out about WI to her and her instance response was "I love it".

When I first tried to call, Pearl's line was busy. She told me at about 8:00 every evening for 15-30 minutes she talks to a friend to catch up on the day and have some good conversation. I love the idea!

Pearl quizzed me on where I lived and then shared, she had ordered Chinese food from the Golf Course and her Fortune Cookie said she was going to hear from someone far away! I guess Mountain Road to Fisher Branch could be considered far away. Thanks for the visit, Pearl.

#### MWI AGM 2021 Wrap Up Report

AGM 2021 was coordinated by the Executive Committee, planning started off with a review of the AGM 2020 evaluation report and preparation began. The MWI Board realized that provincial health restrictions and COVID-19 were determining that AGM 2021 would need to be conducted via a mail-in ballot again this year.

The concept of a virtual AGM was discussed but remained as a mail-in AGM due to the non-existent or limited internet service in many areas of Manitoba and the inability of many members to participate in a virtual AGM due to their technological awareness.

The mail-in AGM was very successful with 67% of the membership submitting their vote to accept and approve Bylaw 2021 and the MWI business regularly conducted at an AGM. Costs to conduct the mail-in vote came from the monies saved from not holding the in-person 2021 AGM.

8.6 Improved Long Term Care Facilities to meet Present & Future Needs submitted by the Manitoba Women's Institute Individual Members: Joan Clement, Lynne Hopley, Elaine Thomson, Enid Clark, and Marion McNabb.

Motion: Moved by Janice Harrison, the MWI Resolutions Committee chairperson, that the Resolution of the Individual Members regarding increased Federal transfer payments for Health to the province of Manitoba to recognize the increasing need in long-term health care facilities, encourage construction of not-for-profit vs for profit facilities, build accountability into funding, and encourage the modification of the Federal Infrastructure program for long-term facility builds and upgrades be accepted. Seconded by Lynne Hopley.

I accept and approve of the Resolution as described in the February newsletter.

#### **Comments and Questions- Annual General Meeting Ballot Count 2021**

(Comments in bold print are responses from the board)

- It has been a privilege to be a part of the formation of the two resolutions from Domain WI. I have never felt the power of women in the WI, to affect change so strongly!
- I have to admire all those women who put pen to paper in an effort to make the world around us a better place.
- Just a comment- since we are unable to hold our regular monthly meetings, it is nice, although rare, to meet at co-op (our only store in town) and if able to recognize a masked WI member, have a couple of minutes of chit chat with them!
- Thank you for all your long and hard work to keep MWI alive!
- Great work this year despite Covid!
- Regarding Resolution 8.2 Broad licencing for on-farm slaughter: Most cattle bought off the farm are sent to a butcher shop and inspected by a government rep.
- I agree in principle about licensing for an on-farm slaughter but question the term "broad" that doesn't really provide limits, but it is a good idea in my opinion.
- Regarding Resolution 8.6 Improved Long-Term Care Facilities: The Federal government has spent so much money this year. I feel we will never be out of debt and as it is, we are being taxed too heavily as it is.
- Thank you very much for all the board members and Angela for the great work you have done. It is a difficult time. I greatly miss our monthly meetings and the social time with the ladies.
- Thank you for all the hard work you do!
- Regarding Creation of the Senior's Advocate Officer: I totally agree with the suggestion of the "inspection" of the Seniors Advocate, to these residents, be an "unannounced" visit to keep these facilities (and staff) on their toes. Too many things have not been properly done or looked after as has been proven during this pandemic.
- I am curious how the resolutions are being worked on. Are there committees? There is a Resolutions Committee as well as resolutions that are submitted by members. For more information on how to submit a resolution, please contact the office. The MWI Board advertises each year in our newsletter for volunteers to sit on committees. If you would like to join the Resolutions committee, please contact Angela at the MWI office.
- I would suggest membership receive updates on resolutions. There are many resolutions over the years, and it leads to the question, what is the status of them? Thank you for this suggestion, from this point forward, correspondence regarding the resolutions will be noted in our board meeting minutes that can be found on our website at mbwi.ca
- In retrospect, perhaps a \$40,000 dollar loan was ill advised in these uncertain times. The CEBA loan is a loan that when paid back by the due date, enables us to keep \$10,000, that does not need to be paid back . Plans are in place to have the loan paid off by the deadline, which will result in \$10,000 of income for MWI, which was needed due to funding cuts in 2020-21.
- The resolutions are all excellent, my compliments to all those contributing to them. Last year when Covid hit, we had no way to communicate except by this format. This year we could have used Zoom concept to get better involvement and discussion. Would at least give more weight and validity to resolutions. Thank you for this suggestion, if Covid is still an issue next year, this is being considered. There is an issue, however, that many members are uncomfortable using zoom or unable to use zoom due to the lack of internet coverage throughout Manitoba.
- You have a pretty small Executive with so many vacancies. Thank you for this comment, we have been actively trying to fill the vacancies, the two positions currently empty are the Northwest Regional Rep and a Rep from the University of Manitoba Faculty of Agriculture.
- It is time to appoint new auditor/reviewer. Have had in place for four President terms and should look at changing. Thank you for this suggestion. Several accountants were contacted and asked to provide a quote but failed to produce a tender for their services by the deadline needed.

- I am deeply grateful to Debra. She typed this complete writing form drove around to see where I lived then the next evening met and delivered the package to me, even with an addressed envelope with a stamp, all ready for mailing. THANK YOU, DEBRA!! Mrs. R. it was a pleasure meeting you and I will be back for tea when the world straightens out.
- After 71 years of questionably active WI membership, I feel I can let the younger "gals" take over. Thank you for your years of service. MWI like any organization is best served by a combination of experienced members and younger "gals" with new ideas and energies. We hope to continue to have both and have been fortunate to have new members of all ages join.
- Duties of board members #18 f- Ensuring Board members sign a Code of Conduct at first meeting of newly elected board. This, to my knowledge, has never been fully explained. I was on the Provincial Board many years ago and no such thing was ever mentioned. Where, who, and why has this become an item when you go on the Provincial Board? This issue has become an expectation by Insurance Brokers, Funding Bodies, Governmental officials, and Directors of Boards who do not want to be held legally and financially responsible for the inappropriate actions of fellow board members.
- Was the Forever Fund included in the financial report? I would not find it under "Forever Fund" The Forever Fund is invested in two separate accounts and totals over \$50,000. The renaming of the fund was changed approximately 8 years ago and is the subject of our current discussions to make the year end financial statement easier for members to understand.
- Note Wording for resolution 8.1: the word "committee" is missing. Thank you we will add in the word.
- Regarding 5. Ratification of the work of the MWI Board: But this does not make much sense because we cannot change what the board has already done. Should we not be making a motion to ratify the work of the 2021-22 board as the board will not be doing the work they already did. Congratulations to the board and Angela for doing such a great job of holding our organization together during these stressful times. Your efforts are truly appreciated. Ratification of the Board's work has been a tradition of MWI and is not required by law. The Board will certainly discuss your thoughts and appreciate your suggestion.
- Good work on thoughtful resolutions- very pertinent for the world today. Thanks to all!

#### Resolution Suggestions- Annual General Meeting/ Ballot Count 2021

Changes to the education system: Background – the proposed system removes local input from people who are elected and accountable. The report they refer to have many suggestions/concerns like poverty etc. affecting student outcomes. Unfortunately, the government only focuses on 1 thing- that gives provincial government 100 percent control of the education system This means schools/parents/students have no say/ input into education- except there volunteers, parent boards, that have no authority.

Concern re childcare: Manitoba government plan on removing pension for staff, changing required education, elimination positions that monitor/oversee daycares, eliminating nursery school, giving little access to those looking for part time enrichment/care

We should be increasing pay etc., value those who care for our children. Inadequate funding and training= inadequate care

2. Garbage/Litter: Background - concern expressed about what garbage is in our ditches. Last year I started a "ditching project" For 6 weeks in the spring and 4 weeks in the fall I walked the ditched picking up garbage. Initially I was picking up beer cans because they are worth 10 cents a can. I was raising money for attending a dragon-boat festival (Waves of Hope team). During the process, I found I couldn't walk past the other cans, plastic bottles and general garbage. I stated keeping track of the amount. Once the weather clears, I plan to do another 6 weeks in the spring and 4 in the fall. This way I can have concrete data. My goal is to paint a picture for our government to implement a return policy as done in Saskatchewan for aluminum cans (pop, energy drinks and plastic bottles. Our ditches have become dumps.

Another submission: Liquor bottles (cans, drink) has a return cash in Saskatchewan, we pay deposit, where does our money go?

3. Purple Martins: Background – the migratory flight path of Purple Martins. Would be great to abstract a colony or spread Purple Martin Awareness.

Dr Kevin Fraser is highly regarded by PMCA.

Dr Fraser is an assistant professor in the Department of Biological Services U of M would be an expert on Purple Martins (Manitoba likely has a provincial society also)

- 4. Petitions e-3189: Background – House of Commons regarding horses being exported to Japan for human consumption. If more would sign this it has to be stopped. This is horrific. As seen on W5 and local newscasts. These horses are being shipped out of Winnipeg, Calgary and Edmonton If we could mention this in our newsletter the deadline for this petition is June 18<sup>th</sup>, 2021. You can also Google horseshit.ca Jann Arden is leading this campaign among other celebrities and the Canadian Horse Coalition (a very worthwhile cause). The horse from Anne was rescued by them. Thank you!
- 5. Rehabilitation for Drug Users: Background – My resolution that I would like to suggest for next year is provide rehabilitation for all incarcerated people with alcohol and drug addictions.
- 6. Offset cost of Medications: Background – Offset the cost of experimental medication not covered by Pharmacare and for those who do not have adequate private insurance and show a significant increase in quality of life with the use of the medication. (my daughter suffers from debilitating migraines prior to this medication, such as going to the emergency department at least 3 times a month. With migraines that take away her vision and sensations in her hands and cause excessive vomiting lasting a few days to a week. She has now been on this experimental medication for 1.5 years and is no longer covered under my insurance. The cost of this medication is \$800 a month and is no longer affordable. Since she has been put on this medication, she has only experienced1 migraine and that was when she first started taking it. With this medication, my daughter is a contributing member of society and without it is disabled. Off set costs for people who live in rural communities who require frequent medical appointments i.e., Cancer Care.
- 7. Enhances Involvement Internationally: Background – As a participant in the United Nationals Commission on the Status of Women (in person in New York 2018-CSW62 and 2019- CSW65) I would like to see increased participating of WI women in Manitoba and Canada. It will he held virtually until at least 2022 and probably for several more years, and even when physical meetings in New York resume, the virtual aspect is expected to continue so our members here in Manitoba can participate from home. I have already discussed this with our national FWIC president, and we are looking into restoring FIWC ECOSOC (Special UN) status.
- 8. Other Suggestions: Abolish Daylight Savings, household batteries collection bins in all communities, hazardous waste and electronic waste collection at all municipal dump stations, reduction in plastic bottles, use of refund glass bottles, raise taxes on pop and beer cans to reduce the usage, body camera for all RCMP and other police officers in Manitoba, provision of a Mental Health Advocate to assist the mentally ill and their families access services and court decisions in a fair and timely manner.



At the FWIC board meeting on May 19, 2021, a motion was made to sell the Adelaide Hunter Hoodless museum and property. Present at the meeting were all the Provincial Representatives and most of the Provincial presidents, who were not able to vote.

The idea for the sale originally came out of a strategic planning meeting, in February 2020, when it became apparent that a balanced budget had not been possible for many years.

I could go into a lengthy detail telling you about the cost savings and fundraising that this board and past ones have done, to try and make ends meet. The saddest part of all is the failure of our hopeful renovation of Addie's Kitchen. The troublesome issue of Covid 19 and the forced closure of the museum because of social distancing was the straw that broke the camel's back.

Creative ideas for improving our financial picture came to no avail, and in reviewing the bleak picture, the motion was made to sell the property which has been part of our organization since 1959. This is a historic moment in our history that will remind us of our roots, formed to be the national voice for the members since 1919, and now we can move forward with that objective in mind.

A realtor has been chosen, and now begins the task of downsizing and determining careful dispersal of the collection. I know there are many questions and concerns that will arise and my board will meet them head on, responding with clarity, common sense and, especially, compassion for the issue. It was not an easy decision to make, but it was felt that the operation of a museum and its maintenance was not the future direction that FWIC/WI Canada needed to take.

Please give us your support while we go through this process, and know that we are ever hopeful that it will strengthen our organization and give new purpose to the reason we were formed over 100 years ago.


She was also very involved in the Waskada History Book committee. Fran loved to play cards, liked western and old-time music. She and John square danced for many years with various clubs.


