Computers and social media constitute a love/hate relationship for many people but in the COVID-19 era they brought me happiness and made me feel closer to people even if it was only on the screen of my computer or iPad.


We all know friends or family that lost loved ones due to COVID. They suffered horribly because they were unable to be with them at the end. We have lost members of our extended family and have been unable to be there to help family grieve through visits and funerals. It has changed our lives drastically; we wonder if we ever will adjust to the new normal.

As the dangers of infection increased, as staff became ill and residents succumbed to the virus, the government imposed necessary restrictions on care homes. No longer could Mom see her loved ones. She became lonelier. We decided it was now time to bring her to our home.

Every time I think of the pandemic which eventually took my dad's life, I remember the happy times that our family shared. His memory will always remain with me. I will miss him to the day I die, but will always cherish the love of poetry and music that he instilled in me.

## Report on AGM 2022

## Results of the Mail in Vote in lieu of an In-person AGM

AGM 2022 was coordinated by the Executive Committee, planning began in late fall when it became clear that COVID-19 restrictions and the concern of members about gathering in groups outside their close contacts would make holding an in-person AGM unrealistic.

Once again we considered a virtual AGM but due to non-existent or limited internet service in many areas of Manitoba and the inability of many members to participate in a virtual AGM due to their technological awareness we chose to rely on a mail-in vote. Based on the positive feedback, we received regarding each member being able to cast their vote by mail, we believed a mail-in AGM vote was the most fair to all members.

The mail-in vote was again very successful with 121 members (68%) choosing to submit their vote, 1% more than last year. Costs to conduct the mail-in vote were two fold with half of the mail out covered by our in-kind services provided by the Manitoba Government under our in-kind agreement with the other half of the cost coming from the monies we saved in not holding an in-person 2022 AGM.

Thank you everyone for your votes, feedback and resolution ideas. Attached for your information are the vote results, the feedback/comments, future resolution ideas, and the answers to questions submitted by members.

Please remember that we are available to answer questions and discuss ideas any time throughout the year by either emailing or phoning a board member. Our contact information is always on the second page of every newsletter.

Thank you for your dedication to our Manitoba Women's Institute.

The process we used for calculating the votes was that on the morning of May 9<sup>th</sup>, 2022, Angela Pickett, Executive Administrator, along with two volunteer Scrutineers, Leanne Sprung, MB Agriculture Leadership Specialist and Dawn Krinke, retired 4H Manitoba Executive Director met at the MWI office to count the ballots.

On the morning of the count, the ballots were split into 3 piles and opened by the three scrutineers. All envelopes at that point were disposed of, therefore not identifiable to who had sent in the ballot.

The ballots were counted, the scrutineers recorded the votes, and then recounted to ensure all were counted. The numbers were compared, there were no discrepancies, and the three scrutineers had matching totals.

MWI Resolution 2022-1

Improving Wait Times for Mental Health Services in Manitoba submitted by sponsors Denise Joss, Peggy Bradshaw, Jacqueline Chartrand, Trish Masniuk, Rose Chopp.

Motion: Moved by Debora Durnin-Richards, the MWI Resolutions Committee chairperson, that the Manitoba Women's Institute urge the Minister of Mental Health and Community Wellness and the Government of Manitoba to increase availability for timely Mental Health Services in the Province of Manitoba. This may include but is not limited to increasing staffing of existing community mental health service therapists, suicide prevention workers, counselors and specialists; increasing private mental health care services; subsidizing private mental health care services; tracking major outcome statistics (wait times, frequency of follow-up, referral to specialist care) with the aim of reducing delays and increasing timely service. Seconded by Jacqueline Chartrand.

MWI Resolution 2022-2

Compassionate decision-making processes in the placement of family members in a Manitoba health care fa**cility** submitted by the Domain WI.

Motion: Moved by Debora Durnin-Richards, the MWI Resolutions Committee chairperson, that the Manitoba Women's Institute urge the Ministers of Seniors and Long-term Care, and of Mental Health Community Wellness, and the Government of Manitoba to reconsider its policies and practices related to moving patients/ residents to hospital and care home facilities. When a person must be hospitalized or placed in long term care, such decisions used to determine location of placement should include, but not limited to the physical address (community) of the loved one/primary caregiver and the distance to and from the placement location; the primary caregiver's mobility, health and ability to access the placement locations; the financial impact and ability to pay costs associated with accessing the location of the hospitalized/in-care person; the challenges the primary caregiver may face in accessing said location (i.e. other people in their home they are caring for such as children, elderly parents or other dependent persons). Such policies and practices should be implemented without causing harm and hardship to the patient/resident or the caregiver(s). Seconded by Janice Harrison.

#### MWI Resolution 2022-3

Cell phone coverage in rural Manitoba resubmitted by the Manitoba Women's Institute on behalf of the Fisher Branch WI and Fork River WI due to the inadequacy of implementation of equitable cell service for all rural, northern and agricultural areas.

Motion: Moved by Debora Durnin-Richards, the MWI Resolutions Committee chairperson, recommend that the Manitoba Women's Institute in solidarity with the Fisher River, Peguis and Jackhead First Nations and the Rural Municipalities of Fisher and Armstrong, recommend that the Government of Manitoba and the Canadian Radiotelevision and Telecommunications Commission (CRTC) require all telecommunications companies operating in Manitoba provide full cell phone service and coverage in all rural, northern, and agricultural areas within six (6) to eighteen (18) months. Seconded by Debra Barrett.

Internet Coverage in Manitoba resubmitted by the Manitoba Women's Institute on behalf of the Marketing and Promotion Committee, Manitoba Women's Institute.

Motion: Moved by Debora Durnin-Richards, the MWI Resolutions Committee chairperson, that Manitoba Women's Institute request the Government of Canada and Manitoba and the Canadian Radio-television and Telecommunications Commission (CRTC) to require all telecommunications companies operating in Manitoba to provide full high-speed internet coverage to all rural and remote areas of Manitoba within six (6) to eighteen (18) months. Seconded by Ann Mandziuk.

Response – yes, it was sent to all members with an email along with the Annual Report via email, and for those without an email, the financial statement was sent with the Annual Report by mail.

• Why and how was the position of Advisor added to the board? Is this an appointed position? Is it a voting position? This position is not in our bylaws

Response – When the 2020 Past President was elected to the FWIC Director position for Manitoba the board was left with no Past President. The President asked if the previous Past President would assist the new President in a Past President role and provide historical information and guidance when required. This position has been dropped for this year to coincide with the Manitoba Women's Institute Act.

• Is Debra taking on another 2-year term as President?

Response – When the President Elect did not believe she could assume the role of President and no nominations or volunteers were brought forward for the position. Debra was asked if she would remain in the position, after considering the pros and cons of staying on she agreed with the understanding that a President-Elect must be found to assume the Presidency when her tenure is finished.

If any member is interested in joining the board as President- Elect, please contact the MWI office and we will be happy to provide you with a description of the duties and time commitment.

• What is being done to fill the position of President-Elect (someone who intends to take on the role of President)?

Response – The Board will continue to ask people to consider taking on the President Elect position and ask for nominations or volunteers in newsletters and by email requests to members.

The Board is a relaxed and positive environment with strong Board members. We may not always agree with each other but by not agreeing we find strong compromises that work in the best interests of all MWI members.

#### **Resolution Suggestions**

We have removed the names of those who provided these resolution suggestions or comments. However, we have kept your information in the office records to provide the 2023 Resolutions Committee. Thank you for taking the time to provide your ideas and thoughts.

We would be very glad to receive resolutions on the all of the following issues. If you need help drafting a resolution, please contact the MWI office and we will share your information with the 2023 Resolutions Committee.

1- Time change to coordinate with the USA and eliminate time changes twice a year.

## Response – There certainly is a lot of discussion on this issue of changing to one time zone across Canada and the USA.

2- Over the years I have put a significant amount of time into researching and writing resolutions. Before suggesting more ideas for future resolutions, it would motivate me to hear if any of these resolutions have made an impact and helped to bring good governments legislation and policy development to fruition or at the very least brought about some robust discussion. Does the WI resolution committee conduct this kind of follow up? Maybe this has been done and I just didn't notice?

Specifically, the one resolution I invested the most time in is the one I've enclosed (broad licensing for on-farm slaughter) I worked together with a young farmer who consulted with various people in the industry and did a fair amount of research into what other provincial jurisdictions are doing to decentralize the meat industry. I would love to let this young farmer know what kind of feedback we got to our resolution and if discussion or forward motion on the topic is happening in our provincial halls of power.

Response – With the Governmental focus on COVID and health, plus Government Ministerial changes we decided to resubmit all our resolutions for the past three (3) AGMs to the new Ministers. MWI Boards have traditionally kept members aware of government, business or organization responses to our resolutions. This process has not changed and when we receive a response or have discussions with the Ministers, we will certainly publish the responses in the MWI Newsletter.

3- Since the resolutions of the past few years have been approved by members, is there any reason we cannot re -submit them when we send out this years' resolution letters? I also think we should follow up with a spot in the newsletter about the government responses, so members are aware. Just an idea

Response – This year we did have two resolutions resubmitted for reconsideration to the Provincial Government and the Canadian Radio-television and Telecommunications Commission. This resubmission was due to the inability of Manitoba residents to access governmental services and other organizations due to the service staff working remotely from their homes and not working from their offices; thereby, not answering their office phones.

Any resolutions may be resubmitted at the request of the institute or writers of the original resolution.

4- A resolution idea is to make the intersection at hwy #6 and hwy #236 safer. After closing all the access to the service road, to Lawsons, they thought traffic should detour to #6 and turn left there. A turning lane should be provided for traffic to turn safely there, instead of the round-about I've heard is proposed.

Response – Anyone who has been involved in a highway accident, recognizes your concerns are timely and very important for the protection of our rural and agricultural residents.

5- I wish to emphasize that cell service is not just a northern issue. Agricultural areas are not always covered. In the Lenore/Kenton area we have very spotty service. I was stuck just a mile from home in a snowy, windy day and my cell phone kept dropping my service. It is scary and frustrating to not know if you are going to receive help.

Response – You are absolutely correct, one area with absolutely zero cell service is within five (5) miles of the City of Winnipeg perimeter. In reality many northern areas have excellent cell and high-speed internet, so your comment is very accurate it is the agricultural and rural areas which appear to be most impacted by nonexistent or limited cell and internet coverage.

6- The timing for the cell phone etc. may not be good because of the winter we had and some other priorities e.g., Russian war.

Response - Your comment is relevant with the looming environmental, refugee and war disasters. For many WI members and their families, the issue of cell phones being workable in rural and agricultural areas would serve to assist all residents in getting assistance when needed, such as overland flooding and flash floods.

7- Last year I commented on my interest in environmental concerns. Specifically, the garbage found in ditches. I needed to complete more research for submitting a proposed resolution regarding the need to return aluminum can and plastic bottles for refund. I hope to present to our local WI for this support 2023.

Response – The volume of garbage found in ditches along major highways is becoming a huge problem. Thank you for your voicing your concern!

8- The resolution that was withdrawn to do with psych evaluations for prisoners within the first couple of months after being arrested/held.

Response – The Resolution on timely psychiatric evaluations for prisoners was forwarded to the former Minister of Health's office personnel. This resolution is one that will accompany this year's resolutions and be sent to Ministers Gordon and Johnson.

9- Review the FWIC resolution recommendations for Cross-Canada support in September of 2022 when they are sent to each province.

Response – The MWI representative on the FWIC Board and the MWI President attend every FWIC Board meeting and will be actively participating and furthering the concept of Cross-Canada support for resolutions. Many resolutions although not written by more than one province are in fact issues in many provinces and we look forward to supporting each other.

10- I am hopeful that our health care system will be sufficiently stabilized next year that the government of Manitoba may be open to the idea of re-opening the Mature Women's Clinic that was closed by the current government. When Hon. Stefanson was the Minister of Health.

Response – This issue has been raised more than once in the past couple of months as an issue very important to a huge section of the public.

11- I think we should make a future resolution about providing a youth drop-in center or youth programs possibly subsidized by the local WI Institutes in each of our communities. Youth that have a sense of belonging or a place to go to meet friends or learn a new skill are less likely to get in trouble with the RCMP. They usually benefit by forming friendships and may learn a lifelong skill. My 23-year-old son came to play pickleball with the adult group who were between 35-65. It would have been nice if there had been a place where he could go to spend time with people in his own age group. Youth in small towns may remain there if there were activities to do, and a place to do them in.

Response – Some Institutes and Individual members support local activities for their communities. However, some Institutes do not have the funds to sponsor or subsidize community youth programs. In looking into these concerns, we were told that most youth activities are held in conjunction with Community schools, Municipalities or Local Government Districts. An issue we often hear is that funding may be applied for from health-based government departments however, finding people to dedicate their time to running these programs is very difficult. Adult programs traditionally are structured, coordinated and funded by the adults interested in the activity.

12- Body cameras for all police officers, sheriffs and prison guards/personnel to protect both the person enforcing the laws and those with which they are interacting.

Answer – This issue is very timely as many organizations serving the public legal system are considering and exploring the benefits of using body cameras for those working within the legal system.

13- Elimination of mentally ill persons who have not been criminally convicted from being housed in Manitoba prisons. These persons are often not provided with mental health services of medication. They frequently become abused or housed in bed bug infested areas of the prison as they are unable to speak out on their own benefit.

Answer - This issue certainly is important and corresponds with the resolution MWI members submitted last year about timely psychiatric evaluations for individuals presenting as mentally at risk when coming into contact with the legal system.

14- Request that there be more recycling facilities i.e. cans, glass, bottles and payment for same as Saskatchewan recycles and this would employ more persons – such as handicapped etc. and,

15- -Recycling of all containers which is not being done

Answer – Recycling is becoming more and more popular; however, there are limitations placed on some recyclable products within Manitoba which prevents them from being recycled. An expanded recycling program is deemed necessary by many.

16- That if COVID or other vaccines be given 1<sup>st</sup> to essential works then 80+ this would have saved many lives.

Answer – There appears to be current research which agrees with your view. We appreciate your concern over the lives of those affected by this virus.

17- That COVID long haul persons be given more support, mental, physical etc. as there is little for them at the present due to unvaccinated persons using the hospitals.

Answer – COVID long haul patients are certainly struggling with many issues caused by their ongoing health concerns. We thank you for your concern about the lives of those affected by long haul health issues.

18- That the Province of Manitoba increases the number of employees in personal care homes. At present, the number required is inadequate to provide decent care to those living within the homes. This number was reduced in the 1<sup>st</sup> term of the Pallister government and was already inadequate at that time. Seniors deserve better.

Answer – MWI did receive an excellent resolution this past year regarding the care of persons living in personal care home. These resolutions were voted on and approved by our membership and forwarded to the provincial government.

19- It is time that more investment to be made to support home care services as many people prefer to be cared for at home.

Answer – At home personal care and end of life care are becoming more important to people as their loved one's age and they want to allow these individuals the best care possible while remaining at home, in their familiar and happy surroundings.

20- Full disclosure on the part of the provincial government in regard to medical statics (for example: COVID and wait times for surgeries to name a couple but not limited to above) so the population of Manitoba has current and up to date information readily available to each person in order to make informed personal decisions that affect their life and well-being.

Response – There has been a lot of discussion lately about the actual statistics regarding COVID and its impact on other forms of health care. In the absence of a lengthy resolution process we would suggest contacting both the Minister of Health, the Governmental representative responsible for the COVID response and planning, and the College of Physicians and Surgeons. The staff at these governmental bodies may be able to tell you how to access the numbers you want or take your concern forward to those in decision making roles.




