#### **6.5 SCAP Grant Application**

Through marketing we were looking at how we can use WI to enhance some of our membership branches. Through Fisher Branch they were looking at something to help young farmers in the area, stay young farmers in the area. Some of them were taking on other roles and not taking on farming. Debra sent a SCAP Grant Application thinking even if we received a little bit of farming and could put one or two of these focuses on keeping some of the young people interested in farming, maybe we would come up with one or two programs and put them into the school system. The school is very positive about WI working with them to enhance the student's knowledge base. The majority of the teachers in the area come from farming backgrounds. If by some means we receive some funding, that's where it'll be used and then if our pilot project works, then that could be something we could be looking at for the rest of the province for the future.

**DISCUSSION:** We should be working with Ag in the Classroom in Manitoba, because they have some great resources to getting into the schools. What we found though is that their programming is lower level, and we are looking at the upper levels for grade 9 and up.

Highlights from the FWIC/WI Canada Board Meeting – October 27, 2025

#### 7.10 **MB Agriculture – Thelma Blahey**

The speech from the throne was presented November 18, 2025. Check it out to see some of the promises for rural Manitoba. #### 7.11 **Agriculture & Rural Development – Gisela Nolting**

The Manitoba government banned the possession of wild boars as of September 22, 2025. Wild boars were introduced in 1980s to diversify farm income. Some wild boars escaped farms, and some were let go by farmers. They are a threat to crop production and can also carry deadly diseases.

A Manitoba company from Winkler, Thunderstruck Ag, had one of their innovations featured in Time magazine as one of the 100 most influential new inventions for 2025. The Razors Edge combine concave beat out five other nominations in the agriculture category. The concave is supposed to have lower grain loss during harvest and better flow of material.

Please check out the Young Agrarians Mentorship Program. It is designed for farms in their first ten years of operation. It offers support from experienced farmers, business learning webinars and networking opportunities.

The Manitoba Farm Women's Conference will be held in Brandon November 17-19, 2025.

#### **7.16 ACWW – Gisela Nolting**

At our October zoom meeting we met with our area President Marie Kenny to share updates and projects in our societies. During the session with other areas, we discussed feedback from the two webinars on Rural Women's Day. Coordinators have to report to ACWW and the area president about their work, activities and donations raised. On the International Day of Rural Women ACWW President Magdie de Kock launched an appeal for donations to support ACWW projects under the motto "Strengthen Our Future". There will be a virtual auction.

November 25 is the International Day for the Elimination of Violence against Women. It marks day one of the 16 days of activism. During the 16 days of activism people around the world unite to raise awareness about gender-based violence, challenge discriminatory attitudes and call for improved laws and services to end violence against women for good.



## What is gender-based violence?

The term refers to all forms of violence directed at someone because of their gender. This includes acts that cause or could cause physical, sexual or psychological harm or suffering including threats of harm or coercion, in public or in private life. It is most often used to refer to men's violence against women.

## What are its drivers?

Research broadly shows that this type of violence happens as a result of gender inequality - a system where women and men do not have equal status, power, resources or opportunities in their society and are not valued or respected in the same way.

As a result, the drivers of this kind of violence are distinctly gendered. According to Our Watch, these are:

- 1. Condoning of violence against women**  
When societies, institutions or communities support or condone violence against women, levels of such violence are higher.
- 2. Men's control of decision-making and limits to women's independence in public and private life**  
This can happen in private relationships - where men who control decision-making, limit women's autonomy and hold rigid ideas on acceptable female behaviour are more likely to be violent - and in the public sphere - where men's greater control over power, resources and decision-making sends a message that women have less value and are therefore less worthy of respect.
- 3. Rigid gender stereotyping and dominant forms of masculinity**  
Promoting these has the effect of reproducing the conditions that create gender inequality and underpins gendered violence.
- 4. Male peer relations and masculinity that emphasise aggression, dominance and control**

## Statistics on gender-based violence

- In 2022, **60 women** were killed as a result of gender-based violence in Australia
- Globally, **five women or girls** are killed **every hour** by someone in their own family
- An estimated **736 million women** - almost one in three - have been subjected to physical and/or sexual intimate partner violence, non-partner sexual violence, or both at least once in their life
- 26% of women aged 15 and older** have been subjected to intimate partner violence
- 24% of adolescent girls** who have been in a relationship have experienced physical and/or sexual violence from an intimate partner
- 16% of young women aged 15 to 24** have experienced physical and/or sexual violence from an intimate partner in the past 12 months
- Less than 40% of women** who experience violence seek help of any sort
